Portland Board Meeting

We had a full day of work on the board items. Due to issues with the rose show, we did not start the meeting until 2 pm. The board meeting was well attended, just missing 4 of the 31 board members. I give credit to President Cairns as he kept the meeting moving, and we were done by 7 p.m.

Atlanta presented the ARS with a check for about \$11,300 from the fall convention. Additional money was donated to ARS for maintenance and renovation of the Atlanta and Deep South District Gardens at the American Rose Center. Thanks!

The board approved the previous minutes of the Executive Committee, but postponed the latest one, as we did not get them in time to review. Also at issue was that we don't approve the minutes, only the actions taken by the EC. We asked that the action items be placed separately so we don't have to figure out what those action items were.

The financial picture looks good at the minute, but we could be in the red by the end of the year. There is a new Pooled Income Fund now through Wells Fargo. Contact ARS for more info. Membership has increased to 21,200, but still not enough.

The charters for the Horticulture Exhibitors and Classification Committees were sent back to the committees for more information. The charters for the Ethics, Convention, CR, ARC, and Audit Committees were approved.

Tulsa was approved for the fall 2004 convention. The presentation was made by Blake and Norma Hedrick.

The charter and proposed actions from the Horticulture Judges Committee were met with the most resistance. Part of their recommendation was to go to voluntary seminars, in other words, no more mandatory refresher or seminars for judges. The board voted that down. The board did agree to set the renewal time at four

years, since many other time periods have been quoted. I made the motion and it was approved that starting with the next presidential term, this committee will be made up solely of the district chairmen of judges.

There were several new awards that were approved by the board. The first was three rotating national arrangement trophies, similar to the Rosedale, Hershey and Portland Bowls for horticulture. These will be named for three of the most deserving people in arrangements, Ruth Tiedeman, Betty Pavey and Mildred Bryant. These ladies created the ARS arrangement program, and it is about time they get the recognition they so richly deserved. Congrats to Lew Shupe and his committee on finally getting these trophies approved. They will be available for the fall conventions. Two other national trophies were approved. The President's Trophy is for a collection of three roses in separate containers from a person growing 50 or less roses in their garden. The other is the GardenWeb Trophy for the best horticultural entry at the two national shows. It is for any one stem entry which would include the hybrid tea and mini Queens. Both will take affect January 2002.

I had one agenda item that was approved by the board. The change allows districts with 1,500 or more ARS members to have the option of awarding a second Silver Medal, Outstanding Judge and Consulting Rosarian Award. This takes effect January 2002.

I have been requested to write a sample Rose Arrangement Schedule for District Societies that have never had an Arrangement

Division or would like to update their existing schedule. This is what I consider a basic schedule, which may be expanded to include Special Classes, Table Classes and Dried Roses Classes. If you would like me to e-mail this schedule in a Word file format, contact me at kreg@swcp.com. I am here to help!

If your society presently does not have an arrangement division, please consider adding one. Just come up with a theme and class titles.

DIVISION II – ARRANGEMENTS

Theme of Show

AMERICAN ROSE SOCIETY MEDAL

CERTIFICATES MAY BE AWARDED TO ARRANGEMENTS USING ARRANGER-GROWN, FRESH ROSES, EXCEPT FOR JUDGES CLASSES.

SECTION A - ROYALTY

Traditional Arrangements with all fresh plant material.

1. Class title.

A line, line-mass or mass design.

Award: Royalty Award

SECTION B - ORIENTAL

Arrangements reflecting the Oriental manner.

2. Class title.

A design in the Oriental manner.

Award: Oriental Award

SECTION C - ARTIST

Modern Arrangements.

3. Class title.

A modern design

Award: Artist Award

SECTION D - NOVICE

For those who have won no more than three first-place awards in the Arrangement Division of an accredited Rose Show.

4. Class title.

a. Standard arrangement with no design or material(s) restrictions.

b. Miniature arrangement not exceeding 10" in height, width or depth. No design or material(s) restrictions.

Award: Novice Award

SECTION E - MINI-ROYALTY

Miniature Traditional Arrangements.

5. Class title.

A line, line-mass or mass to exceed 10" in height, width or depth.

Award: Mini-Royalty Award

SECTION F - MINI-ORIENTAL

Miniature arrangements reflecting the Oriental manner.

6. Class title.

Miniature arrangement in the oriental manner not exceeding 10" in height, width or depth.

Award: Mini-Oriental Award

SECTION G - MINI-ARTIST

Miniature Modern Arrangements.

7. Class title.

A miniature modern design not to exceed 10" in height, width or depth.

Award: Mini-Artist Award

SECTION H - JUDGES

Limited to accredited or apprentice ARS Arrangements Judges, judging this show. A special panel will judge this class if necessary.

8. Class title.

a. Standard arrangement with no design or material(s) restrictions. Type of design must be noted on the entry tag.

b. Miniature arrangement not exceeding 10" in height, width or depth. No design or material(s) restrictions. Type of design must be noted on the entry tag.

Award: ARS Visiting Judges Certificate

ARRANGEMENT RULES

1. All roses must be outdoor garden grown and must be of high quality.

2. A rose or roses must be the dominant flower in all arrangements.

3. Names of all roses in each arrangement must be written on entry tag.

4. AG should be written on the entry tag if roses are arranger grown so the entry will be eligible for a medal certificate.

5. One entry per exhibitor is allowed in each class, but an exhibitor may enter as many classes as desired.

6. Accessories are allowed unless stated otherwise in the schedule. Flowers other than roses, and dried and/or treated dried plant material are allowed unless prohibited by the schedule.

7. A card of intent may be included with an arrangement as an explanation of the arranger's interpretation of the theme or class title, unless the schedule specifically forbids it.

8. An arrangement incorrectly placed in one class when it should have been in another will be judged in the class in which it is placed.

9. All exhibits must be the work of the exhibitor.

10. No one but the exhibitor may touch or move an arrangement. However, in extreme circumstances, if all efforts to locate the arranger have failed, an arrangements chairman may carefully move an arrangement.

11. By entering this show given under ARS rules, exhibitors agree to abide by those rules.

12. Specify if the exhibitor must register for the show and if reservations are required, whom to contact. Listing an arrangement consultant is advisable to answer any questions the exhibitors might have.

13. How the show will be staged? Tables? Niches? Are backdrops, bases and accessories optional? Are the miniature arrangements to be staged at eye-level? If there are size or space restrictions, they should be stated.

14. In classes for miniature arrangements, the arrangements must conform to the size specified in each class, and ONLY those roses classified by the ARS as miniature or mini-flora may be used.

15. Time, date, place, and when the arrangement exhibits may be entered.

16. Time, date and when the arrangements may be picked up after the conclusion of the show.

17. Your local society will take all reasonable precautions, but will not be responsible for the arrangements, containers or accessories.

Infringement of the following rules will result in severe penalty:

1. Painted or dyed fresh plant materials, and live

creatures are not allowed.

2. The use of plant materials on the state or local conservation lists is not permitted.

3. The American flag or flag of any country may not be used in an arrangement or as a decoration in any way.

There are but two causes for disqualification of an arrangement:

1. Roses not outdoor grown.

2. Use of artificial plant material.

Rose Arrangement Judging School July 21st & 22nd - Mesa, AZ

The Arrangement School in Mesa had thirty-five participants with sixteen candidates taking the school for credit. Lew Shupe, the National Arrangement Chairman, and Gary Barlow, Region 4 Director, were there to help. Even our own District Director, Steve Jones, was one of the instructors and renewed his Arrangement Judging Accreditation. I want to thank Marylou Coffman and the Mesa/East Valley Rose Society for hosting the event. As usual Marylou was extremely organized and the Mesa Community College was a great facility. I would like to thank Bill Christensen, Carolyn Buman, Shirley Dattilo and Collette Morton for their instructional help.

Lew Shupe thought it was the largest number of candidates they have ever had at an arrangement school. All sixteen of the candidates passed the examination. Of the fifteen candidates from our district, twelve are already Horticulture Judges and the other three will need to take a horticulture judging school in the coming year. IN THE MAGEE GARDEN

A ROSE GARDEN THAT IS MAINTAINED BY THE CALIFORNIA COASTAL RS

It has been 4 years since the first roses were planted in the Magee House Rose Garden in the garden renovation project undertaken by our then-President Mary Ann Thurston and her husband Charlie Thurston. The California Coastal Rose Society members assisted the Thurstons in putting together and maintaining a current viable rose garden in exchange for free rental from the City of Carlsbad for use of Heritage Hall on the site for our monthly meeting get-togethers. That continuing relationship has prospered, and so has the rose garden. I came to California Coastal in 1997 looking for a public rose garden project to play in and found this magical prospect. I have been digging up, moving around, adding rose bushes and in general having a great time of it trying to convince others of my expertise in roses. Thank you for that opportunity California Coastal. In addition to our annual public pruning demonstration in the Magee House Rose Garden, this January our rose society expanded activities and presented its first lecture series on rose culture in the gardens, demonstrated by members for the public in attendance. Also, mature rose bushes and propagations by members were offered for adoption for nominal contributions to the society.

About that same time in 1997 I joined another group, the Carlsbad Arboretum Foundation, which was assuming landscaping maintenance for flower gardens surrounding Magee House with the exception of the Rose Gardens. That group has prospered also and so has the other flower gardens surrounding the historical Carlsbad house. Those gardens have recently been expanded around the house and I am proud to report that our influence with roses has paved the way for inclusion of some fine rose specimens in those flower beds, too. During this past year the Carlsbad Historical Society became the dominant tenant in the city-owned building and current plans are being promoted to renovate the red barn behind the house as a part of the ongoing Magee House historical exhibit.

As a point of information, Magee House was built in 1886 as one of the first homes in the area in the

settlement of the then newly discovered area of Carlsbad. Samuel Church Smith built the house and sold it in 1896 to a retired diplomat Alexander Shipley. Shipley's daughter Florence was raised in the house; married in 1922 and moved to Pauma Valley to live. She moved back in 1941 where she resided until her death in 1974. She bequeathed the home and adjoining land to the City of Carlsbad and a park was developed in the mid 1970s and hardscapes laid out as currently reflected and landscaped. At that time the flower beds surrounding the house and the rose gardens were formalized and planted to some extent.

A current thank you goes to Joe Smith for his latest addition to the Magee Rose garden with the floribunda 'Europeana'. A marvelous dark red, productive variety I have craved for the garden. He planted it as a demo in our January Rose Garden presentation. Thanks also to Geri Minott for two other varieties I have craved. 'Columbus', a wonderful pink floribunda introduction and that great China rose 'Irene Watts', a close look-alike of 'Gruss an Aachen'. Unless I can squeeze in another one or two, it appears the rose bush limit of the two gardens has about finally been reached.



We currently have about 121 rose bushes in the Modern and in the Old Rose/Shrub rose gardens. This is up from our original 40 or so. We have 15 rose families represented with 26 hybrid teas, 4 grandifloras, 24 floribundas, 10 miniatures, 7 polyanthas, 13 shrubs (including David Austin English shrubs), 8 chinias, 6 teas, 4 species, 4 rugosas, 1 moss, 1 bourbon, 1 portland, 1 damask and 1 alba. As the years go by, I have tried to implement a collection of cultivars that would demonstrate some of the variety that the rose world has to offer us. We have a small exhibition garden as gardens go but one that we are proud of and will be prouder as the bushes mature, to show to others. We are also hoping to influence the planting of roses in other areas of the Magee Park. So far about 4 hybrid musks, 4 noisettes, and 3 rugosas are participating.

We at California Coastal are proud of our involvement with the Magee House Rose gardens as we are getting compliments from many directions. Foremost the resident neighbors next to the park have complimented our rose efforts as they see and enjoy the bushes daily and tell us about that appreciation; the homeless using the park daily love the rose bushes, too. The historical Magee House with its attraction for public tourism provides a wonderful venue to exhibit the wonderful variety of roses that exist

as we show them in our gardens. The other gardens at the house also illustrate other ornamental plantings possible in our coastal garden setting. Further, I would like to share complimentary commentary from two other organizations about our involvement, the Carlsbad Arboretum Foundation and the Carlsbad Historical Society, both of whom share the Magee Park with our efforts.



From THE HARBINGER, Winter 2001, Carlsbad Arboretum Foundation Newsletter-- "... going into its fourth year, the Magee House garden is filling out and starting to look as if it could be almost as old as the house ... Our enthusiastic band of gardeners has gradually pushed back the borders of our original plantings We are very grateful for cooperation from the Carlsbad-Oceanside Rose Society, whose workers have practically melded with ours, so that the on-going project is really a joint venture. Leading the troops in this effort is rose aficionado Ivy Bodin with John Futtrell, German and Susan Gutierrez, and Don Miller close on his heels. We start at 9 a.m. on the first Saturday of each month and are usually finished by 11 or so."

From TIMELINES March 2001, The Carlsbad Historical Society -- "Everything's Coming up Roses ... On the first Saturday of every month members of the Carlsbad Arboretum Society meet at Magee Park to maintain the gardens surrounding Magee House. Roses, lavender and sage were planted around the western perimeter of the house in addition to many other perennials. ...On the West side of Magee House, the Modern Rose and the Old Garden Rosebeds are maintained each month by California Coastal Rose Society members, under the expert advice of Ivy Bodin. Late January found society members busy pruning all the modern roses which include numerous examples of hybrid teas, floribunda and miniatures. Many thanks are due to the Arboretum and the California Coastal Rose Society, from the whole community and especially the Historical Society. Come by and see the gardens and drop into the Magee House while you are there."



HOT NEW ROSES!

'BLACK MAGIC', *HT, Dark Red*

My husband talked me into buying this (why do men always go crazy over RED roses?), and so far it's been a dud for me. But, I'll try to be patient, because I've heard many people say it's wonderful. The Grassos even managed to get it in the Court of Honor this past spring.

'BROOKS RED', *HT, Red Blend*

Brooks Red is a sport of 'Signature', the color being a tad darker pink with a hint of yellow at the base. Don't know why they call it "Red" because it isn't. Although my plant is barely one year old, it has produced several very beautiful blooms. I am looking forward to seeing what it does next spring as the plant settles in. My plant is budded onto Fortuniana from Johnny Becnel.

'CAJUN MOON', *HT, White*

I understand that this is a sport of 'Moonstone'. The bloom color is lighter and it has fewer petals, therefore the form is said to be better, especially in spring when 'Moonstone' has a tendency to look cabbagey. The canes of 'Cajun Moon' have far fewer thorns than 'Moonstone'. Only available from Johnny Becnel, and not yet registered nor listed anywhere.

'CAROLINA LADY', *MIN, Medium Red*

This new red mini is going to give 'Miss Flippins' a run for her money. It has a different bloom shape than 'Miss Flippins', more rounded. I predict 'Carolina Lady' will reach the top of the charts in the near future.

'CITY OF CARLSBAD', *FL, Orange Blend*

Lively orange stripes from light to dark. It is beautiful indeed. Not sure yet if it will make it for exhibition, as it is still in a 5-gallon pot. I've got to find a space for this one.

'GEMINI', *HT, Pink Blend*

As the plant matures in its second year, I like this rose more and more. The well-formed blooms have a glowing look to them that will attract the judges. I have added 3 more, but I still worry about size and low petal count in my hot climate.

'FABULOUS', *FL, White*

This new floribunda is getting rave reviews from exhibitors. I hope to see it win some prizes next year.

'GEOFF HAMILTON', *SH, Light Pink*

I believe this light pink Austin shrub has a lot of potential. So far the plant is short and very bushy with good repeat. The blooms were good enough to be included in my winning Griffith Buck National Trophy at Portland. The foliage has been disease free, and the bloom fragrance seems to be light.

'GRACE ABOUNDING', *FL, White*

I saw this white, single-petalled floribunda at our

district rose show last year, and simply had to have it. From Freedom Gardens (Peter & Susan Schneider), the maiden plant has already produced several lovely sprays. I have high hopes for this next year. This is a 1968 Harkness rose only recently introduced in the U.S.

'HOT PRINCESS', *HT, Deep Pink*

Two new plants from Carlton Roses on 'Manettii' are taking off like a weed. Another plant on 'Fortuniana' from Becnel is growing slowly. I've already seen a couple of blooms and they do look hot, hot, hot!

'JILLY JEWEL', *MIN, Pink Blend*

A beautiful new mini from hybridizer Frank Benardella. My plants are vigorous and bloom continually. Super exhibition form, individual blooms and sprays.

'MAVRIK', *HT, Pink Blend*

So far, I like what I see. My two new plants on Fortuniana from Johnny Becnel in Louisiana have finally shot up some good canes with really nice-looking exhibition blooms and long stems. I have high hopes for next spring.

'MERLOT', *MIN, Red Blend*

This is a new miniature from hybridizer Frank Benardella. It is going to be one of next year's Award of Excellence winners. It is wine red with a silvery reverse. I've seen it and it sure looks pretty. John Saville says that it will be available from Nor'East next January.

'MICHEL CHOLET', *MIN, Apricot*

This 2001 Award of Excellence apricot mini appears to be an approved 'Loving Touch'. The color is deeper and takes longer to fade. The form is better, too, as it doesn't have the sunken centers that 'Loving Touch' had. The blooms are on the slightly big size, but not too big. I have several very young plants of 'Michel Cholet' and I'm optimistic about this rose once it gains maturity.

'MILAN', *FL, Red Blend*

Hybridized by Paul Jerabek, and available from Freedom Gardens, this red blend single-petalled floribunda has a lot of potential. The new plant is already producing big sprays on long stems. Smaller blooms and softer red blend than Nicole.

'PEARL ESSENCE', *HT, Light Pink*

This rose is showing a lot of potential, so I put 3 plants into the ground to let them prove themselves. Let's see what she does this fall and next spring when the plants get more maturity.

'SHINING HOPE', *FL, Pink Blend*

Formerly known as Our Lady of Guadalupe, this pink floribunda from J&P is starting to look quite good. Still needs another year to prove herself.

'VETERANS' HONOR', *HT, Medium Red*

Extremely vigorous and prolific bloomer with very long stems. The form and color are excellent, and it refrigerates well. Fairly clean foliage. One problem is crooked and weak stems, or as hybridizer Keith Zary said himself, "soft necks." Still, excellent for garden and exhibition. Always in bloom even in the summer heat.

As our official National Flower, it becomes even one's patriotic duty to participate in this annual review of newer rose introductions. Your voice is important—and for Consulting Rosarians required, by the way—for meaningful results to be tabulated. Last year more than 1800 reporters responded to the call, our best year yet! Our goal is to reach over ten percent of ARS membership to produce reliable data, which will then be published in the January 2002 issue of *American Rose*. The results will also help determine the ratings in the *ARS Handbook for Selecting Roses*. Please help us to achieve another big increase this year by completing the forms published in the July *American Rose* or go to the ARS web site at www.ars.org and complete your results there. The printed forms can be reproduced as needed for distribution and to accommodate the number of roses being reviewed. Review one variety or dozens, but please only evaluate roses you grow (or grew until shovel pruned) from the cultivar list. Help us to involve as many rose growers nationally and internationally as you can.

The good news is we do not have to worry about hanging, pregnant, invisible or otherwise irregular chads to produce accurate results. If you will take a few minutes to read the directions, you will note that the distinction is made between "Garden" and "Exhibition" ratings. Both are needed and while the resultant ratings are indeed subjective, these ratings provide a valuable guide for growers all over the country as they seek new candidates to add to their own collections. Please mail your completed forms to me if you reside in the Pacific Southwest District or to your own District Coordinator, as listed both on the printed forms and on the web site.

Finally, in the spirit of friendly competition some of us do enjoy, again this year prizes will be awarded to the participants in the ARS District(s) with the most reporters and the highest percentage of members reporting! The Pacific Southwest District is in a neck to neck lead against the Deep South District (as of July 31st) and of course we want to not only keep the lead, but to set the example in our support of this important service! WAYS TO LOSE A NEW MEMBER



We work hard to get new members to join our rose society, both local and national. Yet, many of the new members self-destruct and leave. Why? Some of them joined for a freebie or discounted offer. Many just wanted to learn and quit when they found out what they needed. Others I believe are simply scared off. Here are some of the ways to lose a new member:

1. Never talk to the new member when they join. The best way to have someone feel unimportant is to ignore them. I almost quit roses because of this very reason.
2. Get them involved in internal politics right away. A sure-fire way is to get a new member to take sides in a battle they know nothing about.
3. Have long business meetings at each monthly show. At least 15 minutes to an hour will chase away any newbie.
4. At each meeting and in your bulletin, talk only about one type of rose or only about exhibiting. Centering on one type of discipline will send any newbie packing.
5. Talk about how hard it is to grow roses. Make it sound like if you don't spray every exotic chemical, their plants will never look good.
6. If they are organic, tell them all about nuking them with chemicals. Of course, make sure to tell them they are wrong.
7. Tell the newbie they are all wet. Scorn their preferences and favorite rose.
8. Give them lists with weekly feeding using hard to find materials. See if they want to have an exhibitors garden, and have the time to do all this work.
9. Have them rush out and buy all the expensive chemicals to spray their roses with. Don't bother mentioning the typical, and cheaper, items they can buy at a local nursery.
10. Don't bother to tell them about the advantages about joining ARS; just keep complaining about the organization.

As you see, in this article I was being facetious, yet we tend to do this with new rosarians. Stop and think how you would have been turned off roses if people did the same thing to you! Make it simple, make it fun. Keep the members.

THE ARS OFFICIAL LIST OF APPROVED EXHIBITION NAMES

ATTENTION EXHIBITORS: Avoid being disqualified. Make sure you have the correct name, color, date, and class on your entries. JUDGES: Please be careful when giving disqualifications.

Recently I contacted ARS expressing my displeasure with the “*Official List*,” and asked for clarification. The answer I got from Carol Spiers is that since that publication is the most recent publication, it stands as the “latest authority.” The problem is that many judges are using different references when judging, or if they only go by the “*Official List*” exhibitors will find themselves disqualified.

Here is What I Wrote to ARS:

Recently I purchased a copy of the *2001 Official List of Approved Exhibition Names for Judges and Exhibitors* (OL). To be honest, I was not happy about having to buy yet another rose reference book as I believe it is redundant to what is already available. This makes four rose reference books (3 ARS books plus the *Combined Rose List*), and none of them match up. But, I had heard that many changes have recently been made to rose classifications, dates, and color classifications, so as an exhibitor and rose judge I thought it best to have a book that supposedly has the most up-to-date exhibition names and color classes.

When the book arrived, I checked each and every rose that I currently grow. After going over my complete list of 350 roses, I have found a number of discrepancies and questionable listings I would like clarified.

‘Our Lady of Guadalupe’ -- This is the new pink blend floribunda that was introduced this year by Jackson & Perkins. The *Combined Rose List* cross references it with ‘Shining Hope.’ I found ‘Shining Hope’ in the *Handbook* and the *OL* but no mention of ‘Our Lady of Guadalupe’. People have been exhibiting it locally as ‘Our Lady of Guadalupe’ as that is how it is sold at retail.

‘Purple Heart’ – This rose seems to flip flop back and forth every year ... is it a shrub? ... or is it a floribunda? The *Handbook* says shrub, the *OL* says floribunda, the tag on my rose bush that came from the grower says shrub.

‘Berry Berry Grape’ -- This mauve mini is not listed in the *ARS Handbook* nor *CRL 2001* at all, but is listed in the *OL* as ‘Berry Berry Grape’ not ‘Berry Grape’ ... I thought it was supposed to have only one ‘Berry’ in its name, as that is the name under which I obtained it.

‘Jilly Jewel’ – This mini rose is listed as a pink blend in the *ARS Handbook* and *CRL*, but as white in the *OL*. This rose is NOT WHITE! [NOTE: According to ‘Jilly Jewel’ hybridizer Frank Benardella: “Jilly Jewel is pink here, darker outer petals with a lighter center. I did not register the rose, Nor’East did, and I don’t know how they

registered it. They also filed for the patent; it will be interesting to see what color that comes back as.”

‘Anna de Diesbach’ – This hybrid perpetual has a listed date of 1858 in the *ARS Handbook*, but no date is listed in the *Official List*.

‘Rose de Rescht’ – Previously this rose was listed as a Damask, 1940. In the new *Handbook* and *Official List* it states it is now a Portland, and no date is shown. (*CRL* says Damask [P] 1940s re-intro 1950). Judges DQ’d a ‘Rose de Rescht’ at a recent rose show for having no date.

‘Yolande d’Aragon’ – Previously listed as a hybrid perpetual, 1843, this rose is now listed as a portland in the *ARS Handbook*.

SPECIES and OGR DATES: Another problem with the *Official List*, is that most of the species roses, and many of the old garden roses, do not have dates listed.

COLOR CLASS CHANGES: I noticed that several other roses I grow have had their color classes changed, i.e., ‘Child’s Play’ was changed from white to pink blend (FINALLY!), ‘Reiko’ was changed from pink blend to light pink, ‘Amber Star’ was changed from apricot blend to orange blend, ‘Sunset Celebration’ was changed from orange pink to apricot blend, and ‘Gold Medal’ was changed from dark yellow to medium yellow. All these color changes make sense to me, and I accept them as correct.

So now ARS has three different reference books for roses, all published within one year. Exhibitors and judges who want to be current are almost forced to buy all of them because each of the three books do not parallel each other. This is overkill and is causing confusion, because there are many discrepancies. Frankly, I am frustrated! The judges at shows are not all “on the same page” and exhibitors may be unjustly DQ’d. I would like to know which one of these ARS books is the final authority at rose shows? All judges need to know the answer to this question, so that everybody (judges and exhibitors alike) can use the same reference book at rose shows.

I like the idea of having a list of Approved Exhibition Names ... if only I could rely on its being correct (sigh).

I recommend that ARS get the most current list of Approved Exhibition Names online at its web site ASAP. This is the only way for exhibitors to know they have the most up-to-date info. This should have been done long ago, instead of publishing 3 different books simultaneously that contradict each other.

Here is the Answer I Received From Carol Spiers at ARS Headquarters:

My understanding is that the MOST CURRENT publication should be considered THE latest authority (and has always been the policy). So, the *2001 Official List* is the most current and should be considered the latest authority.
